

IRKUTSK CONURBATION

- Permanent population 600 000.
- Total territory 30 700 hectares.

Irkutsk was founded in 1661 and became the capital of East Siberia since of the 17^{th} century.

Currently Irkutsk is administrative and economic centre of the Irkutsk region (767 900 km²), which is a settlement of energy, aluminum, petrochemical and chemical industries. The advantages of central position for transport and the expansion of trade infrastructure consolidated Irkutsk's position in supraregional and regional trading. The city has several universities and scientific institutes of the Russian Academy of Science.

THE CENTRAL HISTORIC DISTRICT (CHD) OF IRKUTSK

In the 19th century, Irkutsk merchants built hospitals, orphanages, colleges, libraries and churches. Old buildings of Irkutsk's centre are a unique cultural, historical and architectural heritage. Because of it's historical value, wide range of cultural amenities and lot of outstanding historical architectural landmarks, which valued as heritage of federal rank, Irkutsk have received a status of historical city in 1970.


Today the inner city of Irkutsk is in the state of simultaneous crisis and fast development. The tertiary sector has become the most important mainstay of center district's economy. The changes in economy have altered the life of the center but its spatial structure is stable and stiff. Traditionally the shops and services are concentrated in the area limited by Karl Marx, Tchekhov, Timirjazev and Litvinov streets (inner city's core). In recent years many shops and services have been emerged in this area. Concentration and mix of services in this area provide an attraction for urban and suburban inhabitants. Firms and companies are prefer to allocate new shops and services within this area. It evokes a further growth of traffic volumes and pedestrian activities.

The studies have shown, that the city's center is overloaded. The street network provides the service level D — E, during the traffic peak period. About 40 percent of signalized intersections reached their nominal capacity. The annual growth of private cars (6-9 percent) permit to predict a fast increase of traffic volumes, parking demand, traffic jams and emission. So, a private car wich is beginning to dominate in the Irkutsk's cityscape, has become the greatest challenge for urban and environment planners and city's authorities.


Another problem concerns the degradation of whole blocks of old traditional wooden houses. Irkutsk have received the status of historical city. The blocks of XIXth century wooden houses forming a context of historical architectural landmarks and a character of the Irkutsk's center. They have been neglected for a long time. So this blocks have no water supply, modern heating, sewerage and stormwater drainage, litter control and other facilities.

A vital question in this respect is a clash of heritage and development. The Central Historic District (CHD) of Irkusk is determined as special zone of zoning code, which was ordered by the City Council in 1998. The zoning code has affirmed general land use categories for CHD: residential subzones, commercial subzones, recreation subzones. The further development of CHD envisions the restoration of old traditional houses as well as preservation of historical cityscape and grid of streets.

The competition will generate the new proposals for the rehabilitation of the historic center of Irkutsk.
